IPM statement

It is the goal of Roseville City School District to implement IPM by focusing on long-term prevention or suppression of pests through accurate pest identification, by frequent monitoring for pest presence, by applying appropriate action levels, and by making the habitat less conducive to pests using sanitation and mechanical and physical controls. Pesticides that are effective will be used in a manner that minimizes risks to people, property, and the environment, and only after other options have been shown ineffective.

Our pest management objectives are to: *(Example: Focus on long-term pest prevention)*

To implement steps in pest treatment that start with prevention and monitoring, use non-chemical practices as the first steps of corrective treatment. Keep accurate records, establish an acceptable threshold for all types of pests and manage our steps of treatment to that threshold. As a list recourse, we use EPA approved pesticides as means of corrective treatment.

Pest management contracting

- Pest management services are contracted to a licensed pest control business.

- Prior to entering into a contract, the school district has confirmed that the pest control business understands the training requirement and other requirements of the Healthy Schools Act.

Pest identification, monitoring and inspection

Pest Identification is done by: Neighborhood Pest Management

Monitoring and inspecting for pests and conditions that lead to pest problems are done regularly by Custodial Staff and results are communicated to the IPM Coordinator.

Specific information about monitoring and inspecting for pests, such as locations, times, or techniques include:

(Example: Sticky monitoring boards are placed in the kitchen and are checked weekly by custodial staff.)

Indoor monitoring boards and outdoor enclosed bait stations are placed as needed across the facilities to identify potential pest issues. In addition, custodial staff does a thorough cleaning of classroom spaces every other day which includes monitoring for indications of pest activity. Maintenance staff also checks for pest activity during the completion of their work orders.

(Education Code Section 16711)
